USMC Fun Facts - Rifle Squad

In the United States Marine Corps, a rifle squad is usually composed of three fireteams of four Marines each and a squad leader who is typically a sergeant or corporal.

Other types of USMC infantry squads include: machinegun (7.62mm), heavy machinegun (12.7 mm (.50 cal.) and 40mm), LWCMS mortar (60-mm), 81-mm mortar, assault weapon (SMAW), antiarmor (Javelin missile), and anti-tank (TOW missile). These squads range from as few as three Marines (60mm LWCM squad) to as many as eight (Javelin Missile squad), depending upon the weapon system with which the squad is equipped. Squads are also used in reconnaissance, light armored reconnaissance (scout dismounts), combat engineer, law enforcement (i.e., military police), Marine Security Force Regiment (MSFR), and Fleet Antiterrorism Security Team (FAST) companies.

On 9 May 2018, it was announced that a USMC squad will be reduced to 12 Marines, with three fire teams of three Marines each with two new positions: an assistant squad leader and a squad systems operator.
