

#### **TODAY WE BURIED A HERO**

August 18, 20020 Written by Henry A. Detering, Lieutenant Colonel, U.S. Marine Corps, Retired

Nov, 1950: General Douglas McArthur was commanding United Nations forces in Korea, from his hotel in Tokyo, After a successful though ill-conceived landing at Inchon he proudly told reporters, "Our boys will be Home for Christmas." McArthur refused to believe intelligence reports that Chinese soldiers were massing along the China-Korea border, and preparing to support the North Koreans.

The country of Korea is a peninsula with the Sea of Japan to the east, and the China Sea on its west. Mc Arthur ordered an assault northward from both the east and west coasts. The U.S. Army X Corps would attack from the west, and the 1st Marine Division, commanded by General O.P. Smith, would attack from the Port of Hungnam on the east coast, along a single road (Rte 10) winding thru the mountains. General Smith was concerned with McArthur's plan and he believed the reports of Chinese. General Smith dragged his feet, disobeyed orders, and prepared for the worst.

General Smith's force of about 8000 Marines marched North and reached the Chosin Reservoir, but things did not look good. The only way in to the Chosin Reservoir, and the only way back out ,was back down Route 10, and the enemy had already blown up the bridge that the Marines had crossed over at Funchillin Pass to the south

General Smith knew he had to preserve A WAY OUT. Captain William Barber, commanding officer of Fox Company, 2nd Battalion, 7th Marine Regiment, had been a platoon commander on Iwo Jima during the second world war. He and his 246 men got the job. They were told to hold Toktong Pass. The pass was to the east and south of the reservoir, and it was the key to protecting Route 10 and a possible retreat.

When Captain Barber saw the hill above the pass he started to sketch a defense plan. He stayed there, alone, sketching, and he sent his driver back to have his executive office march the men to join him. The men arrived at dusk, it was minus 40 degrees, and they were wearing unlined boots and did not have arctic clothing. Captain Barber made his men dig fighting holes in the frozen ground. Some complained, but it saved their lives.

At around 4 AM, Fox Company was attacked by thousands of Chinese. The fighting was fierce, and listening posts were over run. Private Hector Cafferatta, who received the Medal of Honor for his heroic defense, never had time to put on his boots. At least he survived. Others were not so lucky, the moisture in their breath froze to the zippers in their sleeping bags and they were trapped; bayoneted where they lie. It was a long and terrible night.

Men batted grenades with entrenching tools, blinded men loaded weapons for their buddies, and weapons froze. Corpsman kept morphine in their mouths, to keep it from freezing, and they stuffed plasma bottles in their pants. Fox Company soon lost radio contact with the main force of Marines. They were sniped at during the day, and attacked every night. And they were cut-off On their own, Fox Company held the pass for 5 days and 5 nights. Back at Yudam-ni, near the reservoir, a fierce battle raged and it was one of the bleakest days in Marine Corps History. 8000 Marines were surrounded at by more than 60,000 Chinese and North Koreans. General Smith was going to have to retreat. So, he ordered his Marines to "Attack in the opposite direction." And to get out he was going to have to get his men through the Toktong Pass. No one had heard from Fox Company for four days, and they feared that Fox Company had been wiped out.

Lieutenant Colonel Ray Davis, 1st Battalion, 7th Marine Regiment, was ordered to try and save Fox Company's position. His "Ridge-runners" did not expected to find any one alive. When they spotted the Fox Company position the Ridge-runners stopped in their tracks, and many men dropped to their knees. What was left of Fox Company was surrounded by thousands of dead Chinese, almost all of them facing the Fox Company lines. Ridge-runners could not get to Fox Company without walking over the bodies of the Chinese. And at the perimeter, which had been pulled back every night, bodies were piled up as shields. Some of the bodies that the Fox Company Marines had been hiding behind, the bodies on the bottom, were bodies of their fellow Marines.

Only 80 of the 246 men of Fox Company were still standing, and most of them were wounded. Thanks to Fox Company, the entire Marine Division was able to get out of the reservoir, but they still had rebuild a bridge and fight their way back to the coast. The Marines suffered 3600 dead and wounded, almost all of whom were carried out, and 3600 additional casualties, mostly to frostbite. The Army units, to the west, suffered similarly.

I tell you this story because today BILL PATRICK was buried in a simple ceremony in his home town of Oxford, PA. Bill was one of the Corpsman with Fox Company at Toktong Pass. He was one of the Corpsmen who stuffed morphine in his mouth and plasma in his pants. Bill treated the living, and he tried to make the dying comfortable.

Bill survived, and when the battle was over, Bill returned home, married his sweetheart, and got on with his life, QUIETLY. He moved to Oxford, and raised a family. After 31 years Bill retired as Supervisor at the Post office, but he started there delivering mail to the people of Oxford, and that was all most people knew him about him. Bill was a letter carrier.

I recently watched the Speaker of our House of Representatives give an America Flag to the "grieving widow" of a career criminal who had abandoned her and his family six years ago. His funeral was a national event, attended by politicians and televised. He did not deserve to die, but neither did he deserve the recognition he received.

Bill Patrick DID DESERVE the American Flag that draped his coffin, he EARNED it. Bill Patrick is a true American HERO, and it is Bill Patrick's name that every American should know.

# History of the 34 star flag

A 34th star was added to the American flag to recognize Kansas as the 34th state, as it was admitted to the Union on January 29th 1861. The American flag would continue to bear 34 stars until West Virginia became the 35th state on June 20th 1863. Prior to June 14th 1923, when the US Flag Code was constructed, there were no official guidelines on displaying the American flag or any official specifications on the proportions of the length and width or the pattern in which the stars were to be arranged. As a result, American flags made prior to this could have been made in a number of different sizes shapes and star pattern arrangements. The American flag with the circular pattern as seen on this particular design as well as linear patterned flags were
