New Members:

Stephen Charles Annan, who honorably served in the Marines in the early 1970s, applied for membership, provided a copy of his DD-214, and paid his dues. Steve was sponsored by John Abitabilo. A motion to approve Steve for membership was made by Jerry Myers and seconded by Chris Shaw, the motion passed, and he was sworn in as a member of the detachment.

Minutes from Previous Meeting:

The minutes from 9/27/2021 were provided to members prior to the start of the meeting. A motion to accept the minutes was made by Dan Condron and seconded by Jim Copeland. The motion passed.

Correspondence:

The detachment received a thank you from Sister Bernadette of St. Mary's Franciscan Shelter for Homeless Families in Phoenixville for the donation of dinners from our Chicken BBQ fundraiser on 10/9/2021.

Paymaster Report:

Doug Forsythe advised the paymaster's report is currently in the hands of the audit committee and the First Resource statement will not be available until after 11/1/2021. The Commandant said the detachment's IRS 990 form as a nonprofit is due and that paperwork is being prepared which is why the paymaster's report is not available. Doug also thanked Jerry Ross for his assistance in preparing the 990.

Members or Family Members Sick or in Distress:

District II Vice-Commandant Gene Irvin was hospitalized with Covid and was just released today and is recovering at home.

Report of Officers:

Jerry Myers (Golf Committee): said he plans to put the leftover white bag items, which include several golf outings and hotel rooms, on-line with suggested bids and a cut off date. We also have to decide where to hold the golf tournament next year. French Creek Country Club has been suggested. It was pointed out that the Applecross Country Club has been very generous to us. The Commandant said that we held the tournament in August because we have few events in that month.

Sergeant-at-Arms Weaver advised that 31 members were present. Ken said that in the Spring the detachment approved the lighting to be changed to LED tubes which were to cost \$1,777.86. A check was received from the paymaster for that amount. All of the tubes purchased were not needed so we received a credit which was applied to the cost of recycling the old tubes which is required by law leaving a balance of \$139. Ken submitted an invoice for this amount. Doug Forsythe made a motion to pay this amount which was seconded by Dan Condron and the motion passed.

Dan Fitzpatrick said he has been in touch with the Commandant's Own regarding their recording of the Marines Hymn with a suggestion to make it easier to sing.

Bonnie Shaw, Larry Samples, David Keith, Jim Copeland, Pat Powell and Chris Shaw agreed to serve if elected. Since John Abitabilo was not present, it was not known in he was interested in another term as trustee.

Dan Fitzpatrick is stepping down as Junior Vice-Commandant because of health reasons. Doug Forsythe nominated Emil Meiskomer for trustee. Emil said he would serve if elected. There were no other nominations from the floor.

Dan Condron said he would step down as Chaplain because of personal reasons. Ricky Corbitt, III said he would be willing to serve as Chaplain.

Jack Meighan said he would be willing to continue as Adjutant if no one else was interested. Ken Weaver said he had not made a decision about continuing as the Sergeant-at-Arms.

Doug Forsythe said he would continue as Paymaster.

Special Committees:

Jim Copeland (Bingo): The last bingo brought in 612. The next bingo will be 11/6/21.

(Marine Corps Ball): It is scheduled for 11/13/2021 at the Coatesville Country Club. A Bill Haley tribute band will provide entertainment. Tickets are \$50 a person, \$90 a couple. The menu will feature salmon and carved beef. The social hour begins about 5:30 PM with the ceremony starting at 6:30 PM. Approximately 60 tickets have been sold so far. The featured speaker will be detachment member Lt. Col. Mark "Pete" Peterson, USMC retired who was a personal aide to President Reagan for three years and carried the nuclear football.

Dennis Brown (Marksmanship): The last live fire meeting was held in September at Kimberton. Plans to have a detachment match later this year have been shelved because we have so much going on. We will start all over again next year. In all state matches, shooters must be a member or an associate member, however anyone can practice with our team. Pat Powell said that he would provide ammo, targets and pasties to anyone who wanted to practice with our detachment; some weapons are also available. Dan Condron (VAVS): Last year (2019 -2020) we donated 7,050 in cash, \$46,580 in goods of which \$45,000 consisted of pastries brought in by Tom and Barb Logan. The Logans are unable to do this any longer. This year we did not donate any cash and only \$6,000 in goods.

On the fourth Tuesday of the month, our detachment sells pretzels and popcorn at the VA to raise money for the VAVS. This has just resumed.

New Business:

Regarding the replacement of the air conditioning and heating unit, Oliver Heating & Air Conditioning has provided a new quote about \$2,000 cheaper than Haley. Oliver's quote is \$13,025. Jerry Myers made a motion to accept the estimate from Oliver which was seconded by Doug Forsythe; the motion to spend \$13,025 for a new air conditioning and heating unit from Oliver passed unanimously.

Good of the League:

Marine Memorial Sunday will be held on 11/7/2021 at 10:00 AM in West Chester at General Smedley Butler's gravesite at Oakland Cemetery in West Chester.

On 11/10/2022, we will muster at the detachment at 5:30 AM then drive to Hershey's Mill where we will meet Les Rouse and board a bus arranged by Les and drive to Independence Hall in Philadelphia where we will join other detachments in hoisting a thirteen-star flag at 8:00 AM. After this ceremony, we will march to Washington Square Park where we will lay a wreath at the Tomb of the Unknown soldier of the Revolutionary War and play taps. From there we will break off and reassemble at the Friends' Meeting House at 4th and Arch Sts., and have another ceremony honoring Major Samuel Nicholas, the first Commandant of the Marine Corps. Joining us in attendance will be representatives of the USMC, Department of Pennsylvania Marine Corps League and other MCL detachments.

After the ceremony honoring Major Nicholas, we will board the bus and go to the Union League on Broad St. where Les has arranged for us to have lunch and a tour of the Union League.

Following the tour, we will visit the Vietnam and Korean War Memorials. We will return to Independence Hall and lower the thirteen-star flag at 4:00 PM. We will re-board the bus and return to Hershey's Mill. There is a requested donation of \$25 per person to ride the bus. (Uniform will be satin jacket, long sleeve white shirt, black tie, black shoes and black trousers). Doug Forsythe made a motion for the detachment to pick up the \$25 fee which was seconded by Rich Corbitt, Jr. the motion passed.

On 11/10/2021, Lionville Middle School is having their Veterans assembly at 8:00 AM.

Also in November, we will have a Veterans' Day ceremony at Kerr Park in Downingtown at 10:00 AM on 11/11/2021.

Pat Powell said he has a 1917 - 1918 era Marine Corps recruiting poster which he would like to donate to the detachment. It needs a frame.

The Beirut Memorial ceremony was held yesterday at Penns Landing in Philadelphia; Dan Fitzpatrick played taps and there were probably at least 150 people there.
